




3 Register supplier

3.1 What information needs to be filled

- Mandatory fields are marked with * + one contact details needs to be added and one address + Response on the 6 Questionnaire section.
- If you would like to continue the registration later, you can click Save for Later and you will receive email, in which is a link to continue the registration. You may do this at any point of registration.




3.1.1 Company Details

- Company Legal Name: Please fill in your company legal name in latin letters
- Tax Organization Type: Please always select "Corporation"
- Supplier Type: The only option is "Supplier", please select that.
- **DUNS Number:** Please fill in your company's DUNS number.
- Tax Country: Please fill in your company's Tax Country.
- Taxpayer ID: Please fill in your company's local VAT number.
- **Description of Products and Services**: Please describe in this field what kind of products and/or services your company is willing to supply to Nokian Tyres.
- Corporate Web Site: Please fill in your company's web site address is available.




3.1.2 Additional Information

- To make the selection easier, you can first click the arrow down (1) and then click Search.. (2)




- You can leave the Value field empty (3) and click Search (4) to get the whole list of categories

- -> Click Next


3.1.4 Contacts



 - Maximum 11 characters is allowed and NO special characters like ä,ö,å,ü,ê,ó
- Select Country (2)
 - According to country selection the fields below come mandatory
 - Please always fill in as much information as you have
- Fill in at least all the mandatory fields (3)
- Select Address Purpose (4)
 - o Please tick all three Ordering, Remit to and RFQ or Bidding at this point
- Address Contacts (5): Please click the list button (5), Select the user account line and Click OK to close the window
- Now all the mandatory information related to Address is filled in, please scroll the window to right and click OK (6)



3.1.6 Business Certifications

Click the + button and one Certification line will appear



- Classification: Select the certification type (2)
- Certifying Agency: Select Other (3)
- Other Certifying Agency: Write here the certifying agency name (4)
- Certificate: You can add more detailed information about the certification type (5)
- Start date: When the certificate was issued (6)
- Expiration Date: When the certification will expire (7)
- Attachment: You may add the copy of certification here (8)
